

MITOQ SPARTAN NEW ZEALAND TRIP OF A LIFETIME CONTEST
OFFICIAL RULES

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, WHO ARE 35 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY, HAVE PREVIOUSLY PARTICIPATED IN A SPARTAN RACE, AND WHO ARE WILLING TO TAKE MITOQ IF SELECTED AS A POTENTIAL WINNER. VOID WHERE PROHIBITED

The MitoQ New Zealand Trip Of A Lifetime Contest (“Contest”) is sponsored by MitoQ Limited (“Sponsor”), Level 2, 14 Viaduct Harbour Ave., Auckland, New Zealand and is administered by Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI USA 48033.

- 1. CONTEST PERIOD:** The Contest begins on June 5, 2019 at 12:00:00 PM (noon) Eastern Time (“ET”) and ends on June 30, 2019 at 11:59:59 PM ET (“Contest Period”). Administrator’s computer is the official time keeping device for this Contest.
- 2. ELIGIBILITY:** This Contest is offered to legal residents of the fifty (50) United States and the District of Columbia, who are (i) at least thirty-five (35) years of age or older at the time of entry, (ii) who have previously participated in a Spartan Race, and (iii) who are willing to take MitoQ if selected as a potential winner. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, Gold Public Relations, and each of their respective parent companies, subsidiaries, affiliates, and companies involved in the implementation and execution of the Contest (collectively “Contest Entities”) and each of their respective immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Void where prohibited by law. All applicable federal, state, and local laws and regulations apply.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility, as required by Sponsor or Administrator.

- 3. HOW TO ENTER:** During the Contest Period, an eligible entrant must visit <https://www.mitoqspartanztrip.com> (“Website”) and enter his/her valid e-mail address and the information requested on the entry form, which may include, without limitation: his/her first and complete last name (no initials); valid e-mail address; phone number; street address (no P.O. Boxes will be allowed); city, state; and zip code. Entrant must also indicate whether he/she is male or female, provide confirmation that he/she has previously participated in a Spartan Race, and that he/she is willing to take MitoQ as part of accepting the prize if selected as a potential winner. Entrant must then follow the on-screen prompts to provide his/her answer (in 200 words or less) to the following question: “Tell us why you should be selected to join the MitoQ Team to participate in the Spartan Race in NZ”. All required information on registration as well as the question answer are collectively referred to as the “Submission”. **All Submissions must comply with the restrictions outlined in Section 5 below.**

Limit: There is a limit of one (1) Submission per person during the Contest Period. If more than one (1) Submission is received from the same person, only the first Submission received may be considered valid. An entrant who attempts to enter more than the stated limit may be subject to disqualification from the Contest. If it is discovered or suspected that a person has attempted to enter using multiple e-mail addresses or identities, all of that person's Submissions may be declared null and void and that person will not be awarded any prize that he/she might have been entitled to receive and such prize may be forfeited, at the Sponsor's sole and absolute discretion.

NOTE: By entering, each entrant agrees that his/her Submission conforms to the Submission Requirements set forth in Section 5 below and all other terms and conditions in these Official Rules and that Sponsor or Administrator may, at its sole and absolute discretion, disqualify him/her from the Contest if Sponsor (in Sponsor's sole discretion) decides that his/her Submission fails to conform to the Submission Requirements or any other provision of these Official Rules.

4. JUDGING AND SELECTION OF THE WINNERS: At the conclusion of the Contest Period, eligible Submissions will be judged by a panel of qualified judges ("Judges") to determine the winners. There will be one (1) male and one (1) female selected as the potential winners. The Judges will score the Submissions according to the following weighted criteria: (i) Relevance to the Spartan Race: 30%; (ii) Creativity: 30%; and (iii) Relevance to Mitochondrial Health: 40% ("Judging Criteria"). The two (2) Submissions that receive the highest scores (one [1] from all male Submission and one [1] from all female Submissions) will be the potential grand prize winners. The next four (4) Submissions that receive the highest scores will be the potential runner-up prize winners. In the event of any ties, the Submission with the highest score in "Relevance to the Spartan Race" will prevail. If any potential winner is found to be ineligible, does not comply with these Official Rules, is not willing to take MitoQ, cannot travel on required travel dates, or cannot participate on the MitoQ Spartan Race team, he/she will be disqualified and the Submission with the next highest score will be named the potential winner. Administrator's, Judge's and Sponsor's decisions shall be final and binding in all matters pertaining to the judging and selection of the winners. In no event will there be more than two (2) grand prize winners and four (4) runner-up prize winners. Due to the nature of the Contest, Sponsor reserves the right to select less than the stated number of winners in the event a sufficient supply of eligible Submissions is not received. Potential winners will be notified on or around July 5, 2019 by the Sponsor via email at the email address provided at the time of registration. If a potential winner fails to respond to the email within forty-eight (48) hours, or the potential winner otherwise fails to comply with these Official Rules, he/she will be disqualified and a new winner may be selected as determined by Sponsor in its sole discretion.

5. SUBMISSION GUIDELINES AND REQUIREMENTS: Each Submission must comply with the following:

- Submission must comply with these Official Rules;
- Must not contain material that violates or infringes another's rights, including, but not limited to, privacy, publicity or intellectual property rights, including copyright infringement, or legal or moral rights of any third party, living or deceased;
- Must not disparage Sponsor, Administrator or any other person or party affiliated with the promotion and administration of this Contest;

- Must be the original work of the entrant and must not contain images or artwork, music, quotes, parodies or other materials not created by entrant;
- Must not prominently feature brand names, logos or trademarks other than Sponsor's trademarks in any other element of the entry or image, which Sponsor has granted, with respect to the Sponsor's trademarks, entrant a limited license to use for purposes of this Contest;
- Must not have been submitted previously in a promotion or contest of any kind and has not been exhibited or distributed currently or previously in any media;
- Must not contain, facilitate, reference, or use material that is fraudulent, inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous;
- Cannot be sexually explicit or suggestive, unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group, profane or pornographic, or contain nudity or any materially dangerous activity;
- Must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
 - i. gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - ii. the use of firearms/weapons/ammunition, any illegal drugs, prostitution, pornography, nudity, profanity or other adult content, violence, or the use of alcohol or tobacco products;
 - iii. the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Photo or Video was created.

By submitting a Submission, entrant hereby grants permission for the Submission to be publicly posted on the Website or any social media platform, at Sponsor's sole discretion. By submitting a Submission, entrant grants Sponsor an unlimited, worldwide, royalty-free, irrevocable, perpetual, license and right to publish, use, publicly perform and display the Submission in whole or in part, in any way, in any and all media, without limitation, and without consideration to the entrant, for promotional or marketing purposes.

6. PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):

A. Grand Prizes (2): There will be two (2) grand prizes awarded in this Contest ("Grand Prize"). Each winner will receive a trip for two (2), for winner and one (1) adult guest, to New Zealand from July 30, 2019 – August 6, 2019 (departure from US on 7/30 with arrival in NZ on 7/31 and departure from NZ on 8/6 with arrival in US on 8/5), three (3) month supply of MitoQ (for winner only), and the opportunity to compete in the 2019 Auckland City Sprint on August 2-3 as a member of the MitoQ Team (winner only). Trip includes round-trip coach class air transportation for the winner and one (1) guest from a major commercial airport near winner's residence to Auckland, New Zealand (may include

layovers), round-trip air transportation for winner and one (1) guest from Auckland to Queenstown, hotel accommodations (standard room, double occupancy) in Auckland and Queenstown, car service to and from airports in New Zealand, a welcome dinner on August 1, 2019 and a group dinner on August 3, 2019, winner's choice of sponsor selected activity in Queenstown, and a \$1,000 gift card. Winner's guests must be 21 years of age or older. If the winner elects to travel or partake in the Prize without a guest, no additional compensation will be awarded to the winner. Trip must be taken on dates specified by Sponsor. Winner and guests must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the Prize will not be awarded. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having valid travel documents including government identification and/or passports. Winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in this Prize. Travel must be booked at least 7 days in advance. Guest of winner must sign and return a travel liability release before travel will be booked. Winner and his or her guest hereby acknowledges that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the trip. Winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the winner. Sponsor bears no responsibility if any event, element or detail of the Grand Prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of the Grand Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the Grand Prize, minus any unavailable event, element or detail. The ARV of each Grand Prize is \$10,000.

B. Runner-Up Prizes (4): There will be four (4) runner-up prizes available in this Contest ("Runner-Up Prize"). Each Runner-Up Prize is a 3-month supply of MitoQ Supplements. The ARV of each Runner-Up Prize is \$188.85.

C. General: The prizes will not be redeemed or exchanged for cash, except where required by law. In no event will more than the stated number of prizes be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes by re-judging according to the Judging Criteria in Section 4. No prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize. **NOTE: The experience at the Auckland City Sprint may include inherently dangerous activity. Each winner and guest expressly and voluntarily assume the risk of any and all injury and damage that may result from participation in any element of the prize. Each winner and guest acknowledge and agree that the Contest Entities have no responsibility whatsoever for injuries, losses, or damages of any kind that result from participation in the prize. Each winner and guest must comply with all rules, regulations, and restrictions of the Auckland City Sprint. Each winner and his/her guest acknowledge that the Auckland City Sprint may determine who can participate in its activities under its rules, regulations and restrictions. Each winner and guest acknowledge and agree that the Contest Entities have no responsibility whatsoever for losses, or damages of any kind that result if the Auckland City Sprint determines that either the winners and/or his/her**

guest may not participate in its activities under its rules and regulation.

- 7. HOW TO CLAIM A PRIZE:** Before being declared a verified winner, each potential Grand Prize winner must complete, sign, and return a notarized Affidavit of Eligibility/Liability & Publicity Release and a tax acknowledgement (“Affidavit”) within three (3) business days from the date it is e-mailed to the potential Grand Prize winner by the Administrator. The Runner-Up Prize winners will receive their prize within 6-8 weeks after verification. The Contest Entities shall not be held responsible for any delays in awarding a prize for any reason. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the prize, or any winner notification is returned as undeliverable or the potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, or if a potential winner does not answer the initial notification, the Prize may be forfeited. If the prize is forfeited for any reason, an alternate potential winner may be selected. If a prize is unclaimed, unredeemed or any portion thereof returned as undeliverable, it will be forfeited. prizes are not transferable and includes only the items specifically listed as part of the prize. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for the prize won. Approximate retail value is as of the time these Official Rules were printed and the value of the prize may fluctuate. The winners are not entitled to any difference between the ARV and the actual value of the prize at the time the prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner’s responsibility. A prize will only be awarded to a verified winner. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize will not be re-awarded.

EACH GRAND PRIZE WINNER WILL BE ISSUED A FORM 1099 FOR TAX PURPOSES IN THE AMOUNT OF THE ACTUAL RETAIL VALUE OF THE PRIZE AND MUST SUBMIT HIS/HER SOCIAL SECURITY NUMBER, AS REQUIRED BY LAW. ALL FEDERAL, STATE, AND LOCAL TAXES IMPOSED ON THE ACCEPTANCE OF THE PRIZE ARE SOLELY THE RESPONSIBILITY OF THE WINNER.

LIMITATION OF LIABILITY:** By participating in this Contest, entrants agree that the Contest Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents (“Released Parties”) are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail notifications, telephone calls, or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/Internet/website/UseNet accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate

capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Contest; (vii) any injury or damage, whether personal or property(including any injury related to dancing or creating the entry), to entrants or to any person's computer related to or resulting from participating in the Contest and/or accepting a Prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. If Sponsor, in its discretion, elects to alter this Contest as a result of a Force Majeure event, a notice will be posted at the Website.

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY’S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION ACCRUED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

PUBLICITY RIGHTS:** By participating in this Contest, each entrant agrees to allow the Sponsor and Sponsor’s designee the perpetual right to use his/her name, address (city and state), biographical information, likeness, picture and other information and content provided in connection with the Promotion for promotion, trade, commercial, advertising and publicity purposes in all media worldwide including, but not limited to, on television and the Internet, without notice, review or approval and without additional compensation, except where prohibited by law.
